Treasurer Report: Ending bank balance \$42,759.

\$2,050 in sponsorship checks were in today's mail.

State non-profit filing fee taken care of for 2019. Need to send check for Horseman's United Insurance, increased by \$25.

Old Business:

2019 contract has been signed and returned to Miller's Horse Palace.

Raffle tickets need to be ordered. We need the NFR dates and amounts of the two gas cards. Leah to get dates from the travel agent. Dan motion for \$100 and \$75 gas cards. Leah second. Motion carried. Let's try to push people to sell tickets this year and revisit, may need to increase the minimum next year if sales don't pick up this year.

Bridger school will print a flyer and send home with every student. Joliet may do this as well, Gwynn will check. Leah will check with Shepherd school as well. Businesses will allow posters also. Kirstin will make a flyer to distribute.

Website has been updated

Eliminate volunteer position for indoor arena aside from goat tying and roping. Rule book may need updated. Sandy motions to eliminate position as described. Carolyn second. Motion carried.

Goat Tying in the other arena – kids should run in the same order as print out. Post a copy of the running order outside the office. We will need tacks in the supply case
